NOTICE OF 46TH ANNUAL GENERAL MEETING

Notice is hereby given that the **46th Annual General Meeting** of the Members of Purbasha Resources Limited (the "Company") will be held on **Wednesday, 29th July, 2026**, at 12 Noon (IST) through Video Conferencing ("VC") or Other Audio Visual Means ("OAVM") to transact the following businesses:

ORDINARY BUSINESS:

1. To receive, consider and adopt the Audited Financial Statements of the Company for the financial year ended 31st March, 2026 along with the Report of Board of Directors and Auditors thereon.
2. To appoint a Director in place of Ms. Vithika Agrawal Binrajka (DIN: 05211125), who retires by rotation in terms of Section 152(6) of the Companies Act, 2013 and being eligible offers herself for re-appointment.

SPECIAL BUSINESS:

3. To re-appoint Mr. Ayush Modi (DIN: 07007194) as Managing Director of the Company and to consider and, if thought fit, to pass with or without modification(s), the following resolutions as a **Special Resolution**:

"Resolved that pursuant to the provisions of Sections 196, 197, 198, 203 & Schedule V of the Companies Act, 2013 ('Act') read with the Rules made thereunder and other applicable provisions, if any and the applicable provisions of the SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015 (including any statutory modification(s) or re-enactment thereof for the time being in force) and Clause 93 of the Articles of Association of the Company, and subject to such other approval(s), permission(s) and / sanction(s) as may be necessary, the consent of the Members be and is hereby accorded to re-appoint Mr. Ayush Modi (DIN: 07007194) as Managing Director of the Company for a further term of 3 (three) years with effect from 14th September, 2026 upon such terms and conditions including remuneration, perquisites and other benefits as set out herein below:

- Salary not exceeding Rs. 500,000/- (Rupees Five Lakh only) per month, as may be decided / approved hereafter from time to time.
- Reimbursement of medical expenses incurred for treatment of himself and family (wife and children), up to a limit of one month's salary in a year or three month's salary in a block of three years.
- Gratuity at the rate not exceeding ½ (one-half) month's salary for each completed year of service, to be payable on termination of appointment with the Company.
- Provision by the Company of a car with driver for official use.



- Mr. Modi shall not be liable to retire by rotation and he shall not be reckoned as a Director for the purpose of determining the retirement of Directors.

Resolved further that in the event of absence or inadequacy of profit as contemplated under the provisions of Schedule V to the Act in any financial year during his tenure, the aforesaid remuneration shall be paid as minimum remuneration, provided that the total remuneration shall not exceed the ceiling as provided under Section – II of Part – II of Schedule V to the Act or any statutory modification(s) or re-enactment(s) thereof as in force from time to time.

Resolved further that the Board of Directors of the Company, on the recommendation of the Nomination and Remuneration Committee, be and is hereby authorised to alter and vary such terms and conditions of appointment and remuneration payable within the limit specified under Schedule V of the Act as they may deem fit and proper in agreement with Mr. Modi.

Resolved further that the Board of Directors of the Company be and is hereby authorized to settle any question, difficulty or doubt, that may arise in giving effect to this resolution and to do all such acts, deeds, matters and things as may be deemed necessary, proper or expedient for the purpose of giving effect to this resolution and for matters connected therewith or incidental thereto.”

1. The Ministry of Corporate Affairs (“MCA”) and the Securities and Exchange Board of India (“SEBI”) vide its circulars issued from time to time have allowed companies to hold Annual General Meeting through video conferencing (“VC”) or other audio visual means (“OAVM”), without the physical presence of members at a common venue. Hence, in compliance with the said Circulars, the 46th Annual General Meeting (the “AGM”) of the Company is being held through VC. The deemed venue for the AGM will be the Registered Office of the Company.

2. The Explanatory Statement pursuant to Section 102 of the Companies Act, 2013 (“Act”) setting out material facts concerning the business under Item No. 3 forms part of the Notice convening the 46th AGM of the company (the “Notice”) and the details required under Regulations 36(3) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“Listing Regulations”) read with Secretarial Standard on General Meetings (SS-2) issued by the Institute of Company Secretaries of India, in respect of Directors seeking re-appointment at this AGM is furnished as an Annexure to the Notice.

3. In terms of the MCA Circulars and the SEBI Circulars and Listing Regulations, the requirement of sending proxy forms to holders of securities as per provisions of Section 105 of the Act read with Regulation 44(4) of the Listing Regulations has been dispensed with. Therefore, the facility to appoint proxy by the Members will not be available and consequently, the proxy form and attendance slip including route map are not annexed to this Notice.

4. Members attending the AGM through VC or OAVM shall be counted for the purpose of reckoning the quorum under Section 103 of the Act.

5. Corporate Members intending to authorize their representatives to participate and vote at the meeting are requested to send a scanned certified true copy (Pdf/Jpeg format) of the Board resolution / authorization letter to the Scrutinizer by e-mail at cs.amberahmad@gmail.com or to the Company at secretarial@purbasharesources.in.

6. In accordance with the aforesaid MCA Circulars and SEBI Circulars, Notice along with the Annual Report of the Company for the financial year ended 31st March, 2026, will be sent through e-mail, to those Members whose e-mail addresses are registered with the Company / Depositories / Depository Participants / Registrars and Share Transfer Agent (RTA) and through letter containing the weblink of Company’s website where the Annual Report can be accessed to those shareholders whose e-mail addresses are not registered. Members may note that the Notice along with the Annual Report of the Company for the financial year ended 31st March, 2026 will also be available on the Company’s website at www.purbasharesources.in and website of the Calcutta Stock Exchange, i.e. CSE Limited at www.cse-india.com. Updation of e-mail id & mobile no. is mandatory for availing e-voting facility & joining AGM in case of individual Demat Shareholders.



11.Regulation 40 of the Listing Regulations, as amended, mandates that transfer, transmission and transposition of securities of listed companies held in physical form shall be effected only in demat mode.

In view of the above and in order to eliminate risks associated with physical transfer of securities, shareholders holding equity shares of the Company in physical form are requested to consider converting their holdings to dematerialised form. Members may contact the Company's Registrar and Share Transfer Agent for assistance in this regard. Shareholders are requested to make service requests pertaining to issue of duplicate securities certificate, claim from unclaimed suspense account, renewal/exchange of securities certificate, endorsement, sub-division/splitting of securities certificate, consolidation of securities certificates/ folios, transmission, transposition etc by submitting a duly filled and signed Form ISR-4, the format of which is available on the website of the Company's RTA at www.nichetechpl.com.

Members holding the shares in physical mode are requested to notify immediately the change of their address and bank particulars to the RTA of the Company. In case shares held in dematerialized form, the information regarding change of address and bank particulars should be given to their respective Depository Participant.

In order to enhance the ease of doing investment and doing business, SEBI has introduced new measures to simplify the process for crediting securities to investors' demat accounts. SEBI vide Master Circular No. HO/38/13/(4)2026-MIRSD-POD/I /4298/2026 dated 6th February, 2026 effective from 2nd April, 2026, has dispensed with the requirement of issuance of a Letter of Confirmation (LOC) while processing service request. Accordingly, securities will be credited directly to the shareholder's demat account upon submission of valid demat account details along with the latest Client Master List.

12. VOTING THROUGH ELECTRONIC MEANS

- I. In compliance with the provisions of Section 108 of the Act read with Rule 20 of the Companies (Management and Administration) Rules, 2014, Regulation 44 of the Listing Regulations read with the MCA / SEBI Circulars in relation to e-Voting Facility provided by Listed Entities, the Company is pleased to facilitate its Members, to transact businesses as mentioned in the AGM Notice by voting through electronic means (e-Voting). For this purpose, the Company has entered into an agreement with Central Depository Services (India) Limited (CDSL) for facilitating voting through electronic means, as the authorized e-Voting's agency. The facility of casting votes by a Member using remote e-voting as well as the e-voting system on the date of the AGM will be provided by CDSL.

II. THE INTRUCTIONS FOR SHAREHOLDERS FOR E-VOTING AND JOINING VIRTUAL MEETINGS ARE AS UNDER:

- (i) The remote e-voting period commences on **Sunday, 26th July, 2026 at 9.00 a.m. and ends on Tuesday, 28th July, 2026 at 5:00 p.m.** During this period Members of the Company, holding shares either in physical form or in dematerialized form, as on the cut-



off date **Wednesday, 22nd July, 2026**, may cast their vote by remote e-voting. The remote e-voting module shall be disabled by CDSL for voting thereafter.

- (ii) Shareholders who have already voted prior to the meeting date would not be entitled to vote at the meeting venue.
- (iii) Pursuant to SEBI circular no. SEBI/HO/CFD/CMD/CIR/P/2020/242 dated 9th December, 2020 on 'e-voting facility provided by Listed Companies', e-voting process has been enabled for all the individual demat account holders, by way of single login credential, through their demat accounts/website of Depositories / DPs in order to increase the efficiency of the voting process. Individual demat account holders would be able to cast their vote without having to register again with the e-voting service provider ('ESP') thereby not only facilitating seamless authentication but also ease and convenience of participating in e-voting process. Shareholders are advised to update their mobile number and e-mail ID with their DPs in order to access e-voting facility.

Click on company name or e-Voting service provider name and you will be re-directed to e-Voting service provider website for casting your vote during the remote e-Voting period or joining virtual meeting & voting during the AGM.

- (vi) Members holding shares in physical form will then directly reach the Company selection screen. However, Members holding shares in demat form will now reach 'Password Creation' menu wherein they are required to mandatorily enter their login password in the new password field. Kindly note that this password is to be also used by the demat holders for voting for resolutions of any other company on which they are eligible to vote, provided that company opts for e-voting through CDSL platform. It is strongly recommended not to share your password with any other person and take utmost care to keep your password confidential.
- (vii) For Members holding shares in physical form, the details can be used only for e-voting on the resolutions contained in this Notice.
- (viii) Click on the EVSN for the relevant Company Name i.e. **PURBASHA RESOURCES LIMITED** on which you choose to vote.
- (ix) On the voting page, you will see "**RESOLUTION DESCRIPTION**" and against the same the option "**YES / NO**" for voting. Select the option YES or NO as desired. The option YES implies that you assent to the Resolution and option NO implies that you dissent to the Resolution.
- (x) Click on the "**RESOLUTIONS FILE LINK**" if you wish to view the entire Resolution details.
- (xi) After selecting the Resolution you have decided to vote, click on "**SUBMIT**". A confirmation box will be displayed. If you wish to confirm your vote, click on "**OK**", else to change your vote, click on "**CANCEL**" and accordingly modify your vote.
- (xii) Once you "**CONFIRM**" your vote on the resolution, you will not be allowed to modify your vote.
- (xiii) You can also take out print of the voting done by you by clicking on "**Click here to print**" option on the Voting page.
- (xiv) If Demat account holder has forgotten the login password then enter the User ID and the image verification code and click on Forgot Password & enter the details as prompted by the system.
- (xv) There is also an optional provision to upload BR/POA if any uploaded, which will be made available to scrutinizer for verification.
- (xvi) **Additional Facility for Non – Individual Shareholders and Custodians – Remote Voting only**
 - Non-Individual shareholders (i.e. other than Individuals, HUF, NRI etc.) and Custodians are required to log on to www.evotingindia.com and register themselves in the "Corporates" module.



- A scanned copy of the Registration Form bearing the stamp and sign of the entity should be emailed to helpdesk.evoting@cdslindia.com.
- After receiving the login details a Compliance User should be created using the admin login and password. The Compliance User would be able to link the account(s) for which they wish to vote on.
- The list of accounts linked in the login will be mapped automatically & can be delink in case of any wrong mapping.
- A scanned copy of the Board Resolution and Power of Attorney (POA) which they have issued in favour of the Custodian, if any, should be mandatorily uploaded in PDF format in the system for the scrutinizer to verify the same.
- Alternatively Non Individual shareholders are required to send the relevant Board Resolution/ Authority letter etc. mandatorily together with attested specimen signature of the duly authorized signatory who are authorized to vote, to the Scrutinizer and to the Company at the e-mail address viz; cs.amberahmad@gmail.com, secretarial@purbasharesources.in, if they have voted from individual tab & not uploaded same in the CDSL e-voting system for the scrutinizer to verify the same.

III. INSTRUCTIONS FOR SHAREHOLDERS ATTENDING THE AGM THROUGH VC/OAVM & E-VOTING DURING MEETING ARE AS UNDER:

1. The procedure for attending meeting & e-Voting on the day of the AGM is same as the instructions mentioned above for Remote e-voting.
2. The link for VC/OAVM to attend meeting will be available where the EVSN of Company will be displayed after successful login as per the instructions mentioned above for Remote e-voting.
3. Shareholders who have voted through Remote e-Voting will be eligible to attend the meeting. However, they will not be eligible to vote at the AGM.
4. The facility for the Members to join the AGM through VC/OAVM will be available 30 minutes before the meeting and may close not earlier than 30 minutes after the commencement of the AGM.
5. Shareholders are encouraged to join the Meeting through Laptops / IPads for better experience.
6. Further shareholders will be required to allow Camera and use Internet with a good speed to avoid any disturbance during the meeting.
7. Please note that Participants Connecting from Mobile Devices or Tablets or through Laptop connecting via Mobile Hotspot may experience audio/video loss due to fluctuation in their respective network. It is therefore recommended to use Stable Wi-Fi or LAN Connection to mitigate any kind of aforesaid glitches.



8. Shareholders who would like to express their views/ask questions during the meeting may register themselves as a speaker by sending their request in advance at least **5 days prior to AGM** mentioning their name, demat account number/folio number, e-mail id, mobile number at secretarial@purbasharesources.in. OPERATIONS

During the year under review, the revenue from operations of your Company increased from ₹ 195.85 lacs in the Previous Year to ₹ 225.54 lacs in the Current Year. The Operating Income of the Company is derived from a mix of dividend, sale of shares and securities, profit from future / derivatives and interest income. The profit after tax for the year under review has increased to ₹ 122.58 lacs as against the profit of ₹ 47.89 lacs in the Previous Year 2024-25.

SHARE CAPITAL:

Your Company did not hold any public deposits at the beginning of the year nor has it accepted any public deposits during the year under review. The Board has duly passed a resolution in their meeting giving effect to the said statement.

PARTICULARS OF LOAN, GUARANTEES AND INVESTMENTS:

Your Company is a Non-Banking Financial Company ("NBFC") registered with RBI having principal business of making investments and giving loans in the ordinary course of business, hence the provisions of Section 186 of the Companies Act, 2013 (the "Act") do not apply to the Company. Further the Company has not provided any Loan / guarantee / security during the year under review.



RELATED PARTY TRANSACTION:

All Related Party Transactions that were entered into during the financial year were on an arm's length basis, in the ordinary course of business and were in compliance with the applicable provisions of the Act and the SEBI (Listing Obligations and Disclosure Requirements), Regulations 2015 ("Listing Regulations"). MANAGEMENT DISCUSSION AND ANALYSIS

Purbasha Resources Limited is a non-deposit taking Non-Banking Financial Company (NBFC) registered with the Reserve Bank of India (RBI) and classified as Base Layer NBFC as per the Scale Based Regulations framework of RBI. The principal business activity of the Company is making investment and during the year under review the Company had no customer interface. The Company invests in both listed and unlisted companies. During the year under review, the total market value of investments is ₹ 3,033.39 lacs as compared to ₹ 3,076.42 lacs in the Previous Year. The total book value of investments is ₹ 1,364.51 lacs as compared to ₹ 1,169.95 lacs in the Previous Year. The total revenue from operations is ₹ 225.54 lacs as against ₹ 195.85 lacs in the Previous Year. The Company endeavours to evaluate opportunities considering the macro economic conditions both globally and domestically.

INDIAN ECONOMY OVERVIEW

India has consolidated its position as one of the largest and fastest-growing major economies in the world. Despite a challenging global backdrop marked by geopolitical tensions, an ongoing tariff war and elevated external uncertainties, the Indian economy sustained strong momentum during the year under review. As per provisional estimates of the National Statistics Office, India's real GDP is estimated to have grown by around 7.7% in FY 2025-26 as against 7.1% in FY 2024-25, retaining its position as the fastest-growing major economy for the fourth consecutive year, underpinned by resilient domestic demand, a revival in manufacturing and continued strength in services. A defining feature of the year was the rare combination of robust growth with benign inflation, as headline CPI inflation moderated to multi-year lows and remained comfortably within the RBI's target band, aided by a sustained decline in food prices, a favourable monsoon and the rationalisation of GST rates ("GST 2.0") with effect from 22nd September, 2025.

Against this backdrop of easing inflation, the RBI adopted a growth-supportive stance and reduced the policy repo rate by the close of the year, thereby lowering the cost of credit across the system. India's external sector remained resilient, supported by strong services exports, robust remittances and a narrower current account deficit, even as merchandise exports faced pressure from higher tariffs imposed by certain trading partners. However, downside risks persist on account of the ongoing tariff war, global trade fragmentation, geopolitical tensions and volatility in commodity and financial markets, which the Company continues to monitor closely.

OUTLOOK

The NBFC sector has emerged as a vital pillar of India's financial ecosystem, complementing the traditional banking system by expanding credit access across underserved and niche segments. Over the past two decades, NBFCs have demonstrated strong and sustained growth in assets under management and credit disbursement, driven by rising demand across retail, MSME, infrastructure and consumer financing.



The integration of technology, particularly through digital lending platforms, has further accelerated credit delivery, enabling faster onboarding and broadening access to formal finance for millions of borrowers. However, the sector's rapid expansion, particularly in unsecured lending segments such as small-ticket personal loans, fintech-originated credit and certain microfinance portfolios have introduced emerging asset quality pressures.

OPPORTUNITY AND THREATS

India's structural growth story continues to open up meaningful avenues for NBFCs. Rising formalisation of the economy, deeper credit penetration in underserved segments and a young, digitally-enabled population are widening the market for both lending and investment. Public digital infrastructure like account aggregators, unified payments and data-driven credit assessment — lets even smaller, focused players reach customers efficiently and underwrite with greater precision. For your Company, buoyant capital markets, a broadening universe of listed and unlisted investment opportunities and a debt-free balance sheet together create a favourable setting to deploy capital selectively and build long-term value.

As an entity primarily engaged in investments, your Company remains sensitive to sharp swings in equity and securities markets that can affect portfolio value and returns. The sector also faces intensifying competition from banks and larger NBFCs, evolving regulatory expectations, rising compliance costs and periodic funding pressures that weigh more heavily on smaller players — any of which could constrain growth or affect profitability. The Company remains watchful in managing these risks.

RISKS AND CONCERNS

Risk management is integral to your Company's business and central to its long-term resilience. As an NBFC your Company is exposed to credit, liquidity, operational, human, market including interest rate risk. Sharp movements in the securities markets, unforeseen natural events and geopolitical developments could each adversely affect its performance.

To address these, the Company maintains a sound risk framework supported by continuous monitoring and ongoing investment in people, processes and technology, enabling it to identify, assess and mitigate risks effectively and maintain stable risk metrics through the year.

INTERNAL CONTROL SYSTEMS

The Company has an effective internal control system to ensure reliable financial reports, operating effectiveness and overall efficiency. All its activities comply with applicable laws and regulations. The Board of Directors of the Company is responsible for ensuring that internal financial controls have been laid down by the Company and that such controls are adequate and operating effectively.



The Company has adequate internal control systems proportionate with the size and nature of its business being framed in a manner which ensures optimum resource utilisation and strict compliance with all statutes. The Audit Committee reviews the adequacy of the internal control systems and follow-up actions are implemented immediately, if required.

NOTES FORMING PART OF THE FINANCIAL STATEMENTS

1.	General corporate information
	PURBASHA RESOURCES LIMITED ('the Company'), incorporated in the year 1980, is a registered Non Banking Financial Company, engaged in providing finance and dealing in shares and securities. The Company is listed at Calcutta Stock Exchange Limited.
	The functional currency and presentation currency of the Company is Indian Rupee ("₹") which is the currency of the primary economic environment in which the Company operates.
2.	Summary of Significant Accounting Policies
2.01	Statement of Compliance
	The financial statements have been prepared in accordance with Ind AS notified under the Companies (Indian Accounting Standard) Rules, 2015. The financial statements have also been prepared in accordance with the relevant presentation requirements of the Companies Act, 2013. Further, the Company has complied with all the directions prescribed for Non-Banking Financial Companies (NBFCs).
2.02	Basis of Preparation and Presentation
	These Standalone financial statements of the Company are prepared under the historical cost except for certain financial instruments that are measured at fair value at end of each reporting period. Historical cost is generally based on fair value of the consideration given in exchange for goods and services.
2.03	Use of Estimates
	The preparation of separate financial statements in conformity with the recognition and measurement principles of Ind AS requires the management of the Company to make estimates and assumptions that affect the reported balances of assets and liabilities, disclosures relating to contingent liabilities as at the date of the separate financial statements and the reported amounts of income and expense for the periods presented.
	Estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimates are revised and future periods are affected.
2.04	Revenue Recognition
	i) Derivative Income
	In respect of derivative contracts gains / losses on settlement are recognised in the profit and loss statement.
	ii) Dividend and Interest Income
	Dividend income is recognised when the shareholder's right to receive payment has been established (provided that it is probable that the economic benefits will flow to the Company and amount of income can be measured reliably).



	Interest income from a financial asset is recognised when it is probable that the economic benefits will flow to the Company and the amount of income can be measured reliably. Interest income is accrued on a time basis, by reference to the principal outstanding and at the effective interest rate applicable, which is the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to the asset's net carrying amount on initial recognition.
	Sale and purchase of shares and securities are recognised on transfer of significant risks. Sale is stated at net of taxes and charges on transactions while purchases are inclusive of transaction charges and taxes.
2.05	Borrowing Costs
	Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets, until such time as the assets are substantially ready for their intended use.
2.06	Employee Benefits
	Short-term Benefits
	Short term employee benefits are recognised as an expense at the undiscounted amount in the statement of profit and loss of the year in which the related service is rendered.
2.07	Taxation
	i) Current Tax
	Current tax is payable based on taxable profit for the year. Taxable profit differs from 'profit before tax' as reported in the Standalone statement of profit and loss because of items of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.
	ii) Deferred Tax
	Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the Standalone financial statements and the corresponding tax bases used in the computation of taxable profits. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary differences to the extent that is probable that taxable profit will be available against which those deductible temporary differences can be utilised. Such deferred tax assets and liabilities are not recognised if the temporary difference arises from the initial recognition (other than in a business combination) of assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit. In addition deferred tax liabilities are not recognised if the temporary difference arises from the initial recognition of goodwill.
	Deferred tax liabilities are recognised for taxable temporary differences associated with investments in subsidiaries, joint ventures and associates, except where the Company is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future. Deferred tax assets arising from the deductible temporary differences associated with such investments and interests are only recognised to the extent that it is probable that there will be sufficient taxable profits against which the benefits of the temporary difference can be utilised and they are expected to reverse in the foreseeable future.



	The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.
	Deferred tax liabilities and assets are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset is realised, based on tax rates (and tax laws) that have been enacted or substantially enacted by the end of the reporting period.
	iii) Minimum Alternate Tax
	Minimum Alternate Tax (MAT) paid in accordance with the tax laws, which gives future economic benefits in the form of adjustment to future income tax liability, is recognised as an asset in the balance sheet when there is convincing evidence that the Company will pay normal income tax during the specified period and it is probable that future economic benefit associated with it will flow to the Company.
	iv) Current and deferred tax are recognised in profit and loss, except when they relate to items that are recognised in other comprehensive income or directly in equity, in which case, the current and deferred tax are also recognised in other comprehensive income or directly in equity respectively. The current and deferred tax arising from the initial accounting for business combination, are included in the accounting for the business combination.
2.08	Property, Plant and Equipment
	Fixed assets are carried at cost less accumulated depreciation and impairment losses, if any. The cost of fixed assets includes interest on borrowings attributable to acquisition of qualifying fixed assets up to the date the asset is ready for its intended use and other incidental expenses incurred up to that date. Machinery spares which can be used only in connection with an item of fixed asset and whose use is expected to be irregular are capitalised and depreciated over the useful life of the principal item of the relevant assets. Subsequent expenditure relating to fixed assets is capitalised only if such expenditure results in an increase in the future benefits from such asset beyond its previously assessed standard of performance.
	The Company has elected to continue with the carrying value of all of its property, plant and equipment recognised as of April 1, 2019 measured as per the previous GAAP and use that carrying value as its deemed cost as of the transition date.
2.08.1	Depreciation
	Depreciation is calculated on cost of items of property, plant and equipment less their estimated residual value using straight line method over the useful lives of the assets estimated by the company based on internal evaluation and is recognised in the Profit and Loss Account.
2.09	Impairment of Assets
	At the end of each reporting period, the Company reviews the carrying amounts of its tangible and intangible assets (other than goodwill) to determine whether there is any indication that those assets have suffered any impairment loss. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of the impairment loss (if any). When it is not possible to estimate the recoverable amount of an individual asset, the Company estimates the recoverable amount of the cash generating unit to which the asset belongs.



	Intangible assets with indefinite useful lives and intangible assets not yet available for use are tested for impairment at least annually, and whenever there is an indication that the asset may be impaired.
	Recoverable amount is the higher of fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and risks specific to the asset for which the estimates of future cash flows have not be adjusted.
	If the recoverable amount of an asset or cash generating unit is estimated to be less than the carrying amount, the carrying amount of the asset or cash generating unit is reduced to its recoverable amount. An impairment loss is recognised immediately in profit and loss.
	When an impairment loss subsequently reverses, the carrying value of the asset or cash generating unit is increased to the revised estimate of its recoverable amount, but so that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset or cash generating unit in prior years. Any reversal of an impairment loss is recognised immediately in profit and loss.
2.10	Inventories
	Inventories are valued at the lower of cost and the net realisable value.
2.11	Provisions, Contingent Liabilities and Contingent Assets
2.11.01	Provisions
	Provisions are recognised when the Company has a present obligation (legal or constructive) as a result of past event, it is probable that the Company will be required to settle the obligation, and a reliable estimate can be made of the amount of the obligation.
	The amount recognised as a provision is the best estimate of the consideration required to settle the present obligation at the end of the reporting period, taking into account the risks and uncertainties surrounding the obligation. When a provision is measured using the cash flows estimated to settle the present obligation, its carrying amount is the present value of those cash flows (when the effect of the time value of money is material).
	When some or all of the economic benefits required to settle a provision are expected to be recovered from a third party, a receivable is recognised as an asset if it is virtually certain that reimbursement will be received and the amount of the receivable can be measured reliably.
2.11.02	Contingent Liabilities and Assets
	Contingent liability is a possible obligation that arises from past events and the existence of which will be confirmed only by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the Company, or is a present obligation that arises from past events but is not recognised because either it is not probable that an outflow of resources embodying economic benefits will be required to settle the obligation, or a reliable estimate of the amount of the obligation cannot be made. Contingent liabilities are disclosed and not recognised. Contingent assets are neither recognised nor disclosed.
2.12	Operating Segment
	Dealing in shares and securities and Finance were the two primary business segments of the Company. Consequent to the discontinuation of financing activities, the Company's operations are confined to a single segment, namely dealing in shares and securities.
2.13	Cash Flow Statement
	The Cash Flows have been prepared by the Indirect Method. Cash and cash equivalents include cash in hand, balances at banks, cheques in hand and interest accrued on term deposits with banks.



2.14	Cash and Bank Balances
	Cash and bank balances consist of (i) Cash and cash equivalents which includes cash on hand, balance with banks in Current accounts and other short term deposits which are readily converted into known amount of cash, (ii) Other Bank balances which includes balances and deposits with banks that are restricted for withdrawal and usage.
2.15	Earnings Per Share
	Basic earnings per share is computed by dividing the consolidated profit or loss for the year attributable to the equity holders by the weighted average number of shares outstanding during the year. Partly paid up shares are included as fully paid equivalents according to the fraction paid up. Diluted earnings per share is computed using the weighted average number of shares and dilutive potential shares except where the result would be anti-dilutive.
3.	Financial Instruments
3.01.	Classification, Initial recognition and Measurement
	Financial assets and financial liabilities are recognised when a Company entity becomes a party to the contractual provisions of the instruments.
	Financial assets and financial liabilities are initially measured at fair value. Transactions costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets and financial liabilities at fair value through profit and loss) are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. Transactions costs directly attributable to the acquisition of financial assets or financial liabilities at fair value through profit and loss are recognised immediately in profit and loss.
	Equity Instruments issued by the company are recorded at proceeds received, net of direct issue cost.
3.02.	Derivative Financial Instruments
	Derivatives are initially recognised at fair value at the date the derivative contracts are entered into and are subsequently remeasured to their fair value at the end of each reporting period. The resulting gain or loss is recognised in profit or loss immediately.
3.03.	Derecognition of Financial Assets and Financial Liabilities
	The company derecognizes a financial asset only when the contractual rights to the cash flows from the asset expires or it transfers the financial asset and substantially all the risk and reward of ownership of the asset to another entity. Financial liabilities are derecognised when these are extinguished i.e. when the obligation is discharged, cancelled or has expired.
3.04.	Impairment of Financial Assets
	The Company has applied the impairment requirements of Ind AS 109 retrospectively; however, as permitted by Ind AS 101, it has used reasonable and supportable information that is available without undue cost or effort to determine the credit risk at the date that financial instruments were initially recognised in order to compare it with the credit risk at the transition date. Further, the Company has not undertaken an exhaustive search for information when determining, at the date of transition to Ind AS, whether there have been significant increases in credit risk since initial recognition, as permitted by Ind AS 101.



3.05.	Recent Accounting Pronouncements
	Ministry of Corporate Affairs has notified Companies (Indian Accounting Standards) Amendment Rules, 2025 and Second Amendment Rules, 2025.
	<u>Ind AS 1 - Presentation of Financial Statements</u> The amendment relates to classification of liabilities as current or non-current and non-current liabilities with covenants. In the context of classifying a liability as current, it removes the requirement of existence of a right to defer settlement for at least 12 months after the reporting date, and instead requires that the said right should exist on the reporting date and have substance. The amendment also introduces guidance on classification of liabilities with covenants. The company has no impact of these amendments in its classification criteria of current and non-current liabilities.
	<u>Ind AS 7 - Statement of Cash Flows and Ind AS 107 - Financial Instruments</u> The amendment in Ind AS 7 requires to inform users of financial statements of the existence of supplier finance arrangements and explain the nature of the arrangements, the carrying amount of liabilities and the range of payment due dates. Statutory Reserve as per Section 45-IC of the RBI Act, 1934

Statutory reserve represents reserve fund created pursuant to Section 45-IC of the RBI Act, 1934 through transfer of specified percentage of net profit every year before any dividend is declared. The reserve fund can be utilised only for limited purposes as specified by RBI from time to time and every such utilisation shall be reported to the RBI within specified period of time from the date of such utilisation.

Capital Redemption Reserve (CRR)

Capital redemption reserve represents reserve created pursuant to provisions of erstwhile Companies Act, 1956 by transfer of an amount equivalent to nominal value of the Preference shares redeemed. The CRR may be utilised by the Company, in paying up unissued shares of the Company to be issued to the members of the Company as fully paid bonus shares in accordance with the provisions of the Companies Act, 2013.

General Reserve

General reserve is created through annual transfer of profits at a specified percentage in accordance with applicable regulations under the erstwhile Companies Act, 1956. Consequent to introduction of the Companies Act, 2013, the requirement to mandatorily transfer specified percentage of net profits to General reserve has been withdrawn. However, the amount previously transferred to the General reserve can be utilised only in accordance with the specific requirements of the Companies Act, 2013.

Retained Earnings

Retained earnings or accumulated surplus represents total of all profits retained since Company's inception. Retained earnings are credited with current year profits, reduced by losses, if any, dividend payouts, transfers to General reserve or any such other appropriations to specific reserve.
